CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2012 and January 31, 2013 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF DELAWARE COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

RESOLUTION

WHEREAS, the Boards of Supervisors of Cedar, Clinton, Delaware, Jackson, and Jones Counties (collectively hereinafter the "Members") in the State of Iowa have authorized and executed a certain Eastern Iowa Regional Utility Service Systems Intergovernmental Agreement (the "28E Agreement") pursuant to Chapter 28E of the Code of Iowa; and

WHEREAS, the terms of the 28E Agreement provide for the creation of the Eastern Iowa Regional Utility Service Systems Commission (the "EIRUSS") for the purposes of planning, designing, developing, financing, constructing, owning, operating, and maintaining wastewater treatment systems and water systems for and on behalf of the Members and the cities and unincorporated areas within the boundaries of the Members; and

WHEREAS, EIRUSS has authority pursuant to the 28E Agreement and Chapter 28F of the Code of Iowa to issue revenue bonds and interim financing notes to pay the costs of projects undertaken, but prior to the issuance of such bonds or notes each of the Members must adopt a resolution authorizing their issuance; and

WHEREAS, EIRUSS has undertaken the design and construction of a wastewater treatment system (the "Project") in the unincorporated community of Leisure Lake in Jackson County, Iowa and has proposed the issuance of revenue bonds (the "Bonds") and corresponding revenue bond anticipation notes (the "Project Notes") to pay the costs of the Project; and

WHEREAS, it is now necessary for the Board of Supervisors of Delaware County, Iowa to approve and authorize the issuance of the Bonds and the Project Note;

NOW, THEREFORE, It Is Hereby Resolved by the Board of Supervisors of Delaware County, Iowa (the "County"), as follows:

Section 1. The County hereby authorizes EIRUSS to issue the Bonds for the Project in a principal amount not to exceed \$3,000,000 and to issue the Project Note in a like amount anticipating the issuance of such Bonds in order to finance the Project.

Section 2. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed to the extent of such conflict.

The Delaware County Board of Supervisors met in work session this date at 2:00 pm with all members present. Shirley E. Helmricks, Chairperson, opened the meeting at 2:24 pm. The meeting was delayed due to technical difficulties with the speaker phone.

Steve Leonard, President of the Lake Delhi Combined Recreational Facility and Water Quality District Trustees, stated that today's meeting would also serve as an official meeting for the Lake Delhi Trustees since a quorum was present. Mr. Leonard then proceeded to thank the Supervisors for all the efforts the county has put forth to date. The county led the charge in the debris removal immediately after the flood and have begun the demolition of severely damaged structures. The county has also furnished many in-kind services such as offering the services of the County Attorney, County Engineer, County Auditor and County Treasurer, the recent agreement for providing financial services to the district as well as the countless hours spent on the Governor's Task Force, trips to Des Moines and other informational and educational events.

Mr. Leonard then gave the floor to Mr. Pat Colgan, a former Civil Engineer with vast experience in hydroelectric dams and resident of the lake area since 1956. Mr. Colgan summarized the recent 600 page study of the dam completed by Stanley Engineering. According to the study, there were three (3) major areas of the dam affected by the 2010 flood event; water was flowing over the southern embankment which eventually eroded and failed, the gates were damaged and the northern embankment saw significant seepage. Mr. Colgan stated that funding from the Department of Natural Resources was given to assist in the study conducted, which in his opinion was perhaps the most detailed study ever done on a dam, and to design a plan to bring the facility into compliance with current standards. He emphasized that the new dam will be a "modern" dam. Mr. Colgan continued by stating that the study identified the Delhi Dam as a "moderate" hazard dam. Stanley Engineering is currently awaiting a response from the DNR on this determination. The recommended project design is suggested in two phases; Phase One being the restoration of the existing powerhouse and gated spillway structure and Phase Two being the reconstruction of the eroded southern embankment and construction of a new spillway to increase discharge capacity. The preliminary schedule would have Phase One awarded in April 2012 and Phase Two awarded in late June 2012. This would allow restoration of the lake before the summer of 2013 (weather and river flows permitting). The estimated cost of the project is \$11.9 million.

Mr. Leonard then indicated that the Trustees will be providing two (2) copies of the full 600 page report to the County. The Trustees ask that one of these copies be made available in the Delaware County Auditor's Office for any member of the public who would like to review it or make copies from it. He then recapped the estimated economic impact to Delaware County and the cost to taxpayers if the lake does not return compared to what it would cost tax payers if the Supervisors were to contribute \$3 million dollars toward the rebuilding. The Trustees and the Water Shed group are currently working with the Governor and state legislators on possible funding options for the district. They feel it would speak volumes if the Delaware County Supervisors were a funding source as well.

Mr. Leonard then read a formal request for funding from the Trustees of the district. The request was for the County Board of Supervisors to approve a \$3 million general obligation bond in the form of an emergency bond without a public referendum in order to keep the momentum moving forward for the rebuilding project. He continued by saying that the Trustees will be meeting with subcommittees in Des Moines in early February and would like to have a decision before then. He anticipates that the legislators will ask what Delaware County is doing financially for the rebuilding effort. When asked how long they needed in order to make a decision, Shirley Helmricks stated that she would like at least two weeks and asked the Auditor to place it on the agenda for the January 30, 2012 regular board meeting.

Supervisor Ries asked Auditor Carla Becker when the Board would be able to put it to a vote. Ms. Becker responded that the county Special Election dates for 2012 were the first Tuesday of March, May, August and November.

Supervisor Helmricks asked all present to keep the family of James "Buzz" Graham in their thoughts and prayers. This is the first meeting the Board has had with the Lake Delhi Trustees since the passing of Mr. Graham.

This being the date and time set for a Public Hearing in regards to the Proposed Re-Classification of a portion of Hopkinton & County Line Road from a Class "C" to a Class "B", Chairperson Helmrichs opened the public hearing at 1:32 pm.

Anthony Bardgett, County Engineer, stated that through recent research, he cannot find anywhere in the records of the County where the portion on Hopkinton & County Line Road in question was ever vacated or classified. Since there is no record, he must assume that the county's easement is still in existence and that the roadway is classified as a Class "A" roadway even though the county is not maintaining it as such. Since the roadway is currently just a grassy path, he is recommending re-classifying that portion as a Class "B".

Jim Singsank, Secretary/Treasurer of Flatrock Forest Group, Inc., an adjoining land owner to the Hopkinton & County Line Road addressed the Board regarding the events which have unfolded since he heard of the proposed re-classification. He believes that the road should not be reclassified as a Class B since it would allow the general public to utilize it without question. He stated that the roadway actually stops in the middle of Flatrock's property. He has spent a lot of time researching this roadway with Brad Burger, County Surveyor, and Anthony Bardgett, County Engineer. He then outlined in detail what that research entailed. In conclusion, Mr. Singsank stated that, "there is no proof that the Hopkinton and County Line Road exists any longer and there is no tax being deducted for this road from property owned by Kelchen, Knipper, Gudenkauf and Flatrock, and there is no official county plat book in the Auditor's Office which shows there is a road still in place, and that the "ghost road" has no classification now and it is not on any county roads list.

He urged the Board to either dismiss it altogether or to table the issue until more research can be conducted. He thanked the Board for their time as well as Brad Burger and Deputy Assessor Andrea Schmidt.

David Smith addressed the Board in favor of the re-classification of said roadway. His parents are in the process of establishing clear title to property in Dubuque County which could be accessible with this roadway. He requested that the Board re-classify the roadway at least as a Class "B" for the following reasons: Convenience of access. The roadway is much more accessible than the present access in Dubuque County; Safety for his father. Since they do not have to cross a river or walk up steep grade as they do from the east, it would be much easier access for his elderly father; Transportation of equipment. Currently they have to walk the equipment in

to help his father maintain his property; this would allow vehicles to transport equipment in; and finally access to his father's property. Since this roadway is the only public route his father has to access his property without pursuing a private easement from landowners.

Mrs. Rose Smith stated that she has been paying taxes on the property in Dubuque County for 10 years and is very close to receiving a deed to clear title.

Robert Gudenkauf, an adjacent property owner, stated in 1820 it was designated a road. If it isn't a road, then anyone that travels east on the roadway past Knipper's is trespassing, including Mr. Singsank. He is not in favor of gates on the roadway (Class "C").

Ron Kelchen, adjacent property owner, has no qualms with the Smith family going across his property to access theirs. He also is not in favor of gating the roadway.

Anthony Bardgett stated that he had originally intended to propose reclassifying the roadway as a Class "C" and allowing it to be gated. However, he had received a lot of negative feedback on that and thus decided to propose a Class "B". The only difference between a Class "B" and a Class "C" is that a Class "C" roadway can be gated with keys given to adjacent property owners and those using it for access. Since he cannot find any documentation at this time that the roadway has ever been vacated, he must assume that the easement still exists and is a Class "A" roadway.

The Board asked Mr. Bardgett how much time he would need to finish his research in this matter. Mr. Bardgett stated that two weeks would be enough time.

Motion made by Ries, second by Madlom and carried to table the consideration of reclassifying a portion of the Hopkinton and County Line Road for at least two weeks to allow the County Engineer to research the matter further. All Ayes

NEXT MEETING

The next regular session of the Board will be on Monday, February 6, 2012 at 1:15 pm at the Supervisor's Office in the courthouse.

PUBLIC COMMENTS:

Nicole Turpin, ECIA, addressed the Board regarding the progress of the demolition project from the 2010 flood. She stated that five (5) structures have been removed. Four (4) of the structures are below the Hawker resort and the other is the Beatty property. Seeding and grading will be finished in the spring when weather permits. There was some damage done by the contractor. Lansing Brothers has been notified of the damages and is set to replace a retaining wall that was damaged during demolition. A retaining wall near the Beatty property was also damaged along with damage to the roadway. She would like the Board members to do a site visit with the contractor on Wednesday morning to see the damages.

In regards to the other properties set for demolition, all are now deteriorated to the point that they cannot enter them to inspect for asbestos. Even though this may make the demolition more expensive, it will also decrease the amount of paperwork and inspections needed. We are still waiting for FEMA to release the funding for the remaining structures so the county can go out for bids.

Chairperson Helmrichs addressed those present and thanked those who had sent nearly 200 e-mails voicing their opinion on the request for county funding of the Lake Delhi rebuilding effort. She also reiterated that the Board had set February 29th at 7:00 pm as a public forum to solicit comments from the public regarding the Board's upcoming decision. She then opened the floor to those present who wished to make additional comments regarding the funding request.

Patrick Vance, a life-long resident of the county, was the first to address the Board. He stated that much has happened since the first Board meeting he attended back in September of 2010. "A lot of people have made a commitment to get the Lake back", he stated, "Now it is the Board of Supervisors' turn. If you take the emotion out of it and simply look at the facts, it makes sense to go ahead with it."

Several residents of the lake, including John Mack, Nate Dunn, Dave Fry, Daryl Kunkel, Steve Leonard, Pat Dede, Betty Bowers, Larry Aschbrenner, Randy Mahoney, Bruce Schneider, Gary Grimm, Michelle Carton, Bob Klima, Marcheta Coeoy, Greg Bandfield, Dianne Bauers, and Jerry Gotto, reiterated Mr. Vance's comments in favor of the Board of Supervisors funding support.

Many of the property owners spoke not only of the implication of decreased valuations on the taxes of Delaware County residents, but also of the economic impact of the Lake District not being there. Daryl Kunkel stated that he alone brings up to 250 people a year to his cabin. Dianne Bauers stated that a visitor from Hawaii extended his four (4) day skiing trip to two (2) weeks because he enjoyed the area so much. He even called it an "Oasis in the corn fields".

The district was referred to many times as an "economic engine" for the county. Many people spoke of the guests from outside of the county that come and spend money here because of the Lake District.

County residents Ann Wilson-Grant and Steve Dircks stated that they were not residents of the district and have no intention of ever being residents of the Lake District and yet they were both in favor of the board approving the funding. Mrs. Wilson-Grant stated "my late husband used to say 'sometimes you have to spend money to make money'. I really support this."

Norman Boss, resident of Prairie Township, stated he was not opposed to the rebuilding but was also concerned about how the county was going to pay for the \$4 million needed to rebuild the bridge. He urged the Board to be careful how much extra funding they approve for the dam rebuilding knowing that the bridge needs built as well.

There were also several local bankers and business persons in attendance who encouraged the funding approval for economic reasons. Keith Kramer, F & M Bank, stated he did not want Delaware County to find themselves in the same housing crisis that Minnesota and other neighboring states find themselves. He feels that if the dam is not rebuilt, once these people leave they are not coming back to Delaware County. "We are a garden spot to live", he stated. "The lake district is an economic engine for Delaware County. It is what brings in the outside money into the county. Counties fight for tourism dollars like this."

Dave Fry, a member of the Watershed Committee and a district resident, stated that this is a timing issue as well. There have been many hours put in educating the local and state legislators as to the necessity of state and local funding. With this being an election year, all the key players will be changing. Senator Hancock and Representative Steve Lukan are not even running for re-election. Everything would virtually have to start over from the beginning. The Governor is there, the state legislators are there and the local district funding is approved. The relationship between the county and the district has come a long way. He encouraged the Board members to vote yes for the emergency bond. "We need to continue to work together so that Delaware County can reap the benefits that the lake district has to offer" he stated. "The Lake District residents may not be the highest stake holder in this, it may be ALL of Delaware County's residents."

Supervisor Ries stated that when the dam breach happened, they heard the rebuilding would take anywhere from \$3 million to \$15 million. As a Board, they were looking for exact figures before they committed to anything. Just last week they found out from the study that it's estimated at \$11.9 million.

Chairperson Helmricks was the last to speak. She stated that her son who is in FFA has a shirt which says, 'This is where I come from and these are my people'. The members of the Board will be finishing up their individual research in their own way. She understands that the past 19 months have been devastating for some. The county has tried to do what it could with the debris removal and demolition programs. The Board members value everyone's opinions. It is best if you personalize your e-mails and letters rather than just sending a form letter. She had received a phone call from Dick Jones, Lake Resident and former Delaware County business owner, from his winter home in Florida. He told her a story regarding a man named Tom Robinson who owned a cabin in the district. That gentleman liked the area so much he wanted to start a Delaware County branch of the company he worked for. That company was Rockwell Collins.

There being no further business before the Board, Chairperson Helmricks asked for a motion to adjourn.

Anthony Bardgett, County Engineer, read aloud the proposed resolution to change the classification of a portion of Hopkinton and County-Line Road to a Class "B" road. Supervisor Ries asked Mr. Bardgett if the roadway had ever been graded. Mr. Bardgett replied that he has aerial photographs which show the existence of a roadway but he has no maintenance records for it.

It was discussed that if the roadway were to be reclassified a "Level B" roadway, the gate that Mr. Singsank has erected would need to come down. Supervisor Helmricks acknowledged that the Board had received letters from the adjacent property owners as well as a request from Mr. Singsank to table the consideration of said reclassification until he is able to complete his research.

Supervisor Helmricks asked Brad Burger, County Land Surveyor, to discuss what he has done in terms of research. According to Mr. Burger, he has reviewed all the records in the courthouse and the Secondary Roads Department. He has personally reviewed all of the Supervisor Minute Books that Mr. Singsank noted he had not reviewed yet and stated he found nothing in regards to this portion of the roadway ever being vacated.

Mr. Bardgett stated that he feels that every avenue has been exhausted in terms of researching this roadway. He is confident that the county still has a Sixty-six (66) foot right-of-way over this roadway.

28E AGREEMENT

INSPECTION OF CITY SIGNS BY DELAWARE COUNTY

This agreement entered into this 13th day of February, 2012 by and between Delaware County, Iowa, and the City of Colesburg, Iowa.

WHEREAS, both Delaware County and the City of Colesburg are a public agency as is defined by Section 28E.2 of the Code of Iowa, and

WHEREAS, Section 28E.3 of the Code of Iowa provides that any power or powers, privileges or authority exercised or capable of exercise by a public agency of the State of Iowa may be exercised and enjoyed jointly by a public agency of the State of Iowa having such power or powers, and

WHEREAS, it is proposed, that Delaware County will perform a retro-reflectivity inspection on the City of Colesburg's sign inventory as required by the FHWA's minimum reflectivity requirements, and

WHEREAS, Delaware County will perform this inspection once every four years based on the terms of Delaware County's sign reflectivity inspection policy, and

WHEREAS, Delaware County will invoice the City of Colesburg for the time spent on said inspection, based on an hourly rate of inspection staff plus any applicable equipment maintenance fees, and

WHEREAS, the Delaware County Board of Supervisors and the City of Colesburg have informed themselves as to the proposed inspection.

IT IS NOW AGREED that Delaware County and the City of Colesburg enter into an agreement pursuant to Chapter 28E of the Code of Iowa providing for cooperative action pursuant to the proposed roadway construction project and, said cooperative actions include the following:

- 1) **SCOPE OF WORK** – Delaware County will perform retro-reflectivity inspection by the Retroreflectometer Method on the City of Colesburg's sign inventory as required by the FHWA. Delaware County will store the inspection information on the county's GIS system and submit a report back to the city indicating which signs need to be replaced.
- 2) **DURATION** - This Agreement shall commence on the date that both parties sign this agreement and shall continue thereafter until either party wishes to terminate said agreement by written letter.
- 3) **PURPOSE** - The purpose of this Agreement is to accomplish the proposed inspection as described herein in accordance with the aforesaid scope of work and in agreement with conditions specified in this Agreement.
- 4) **ADMINISTRATION** – Delaware County shall be responsible for the administration of this project.
- 5) Delaware County and the City of Colesburg agree to save and indemnify and keep harmless, each other against all liabilities, judgments, costs, and expenses which may in any way come against either party or which in any way result from carelessness or neglect of either party or its agents, employees, or workmen in any respect whatsoever.
- 6) The parties agree to indemnify and hold each other, their employees and agents, wholly harmless from any damages, claims, demands, or suits by any person or persons arising out of any acts or omissions by either party, its agents, servants or employees in the course of any work done in connection with any of the matters set forth in this agreement.
- 7) **FINANCING** – Delaware County will initially bear all costs of inspection of the City of Colesburg's sign inventory. Once said inspection is completed, Delaware County will invoice the City of Colesburg for inspection staff costs and any applicable equipment maintenance fees.

This Agreement is subject to termination by written notice from any party.
