CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2016 and January 31, 2017 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF DELAWARE COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

Section 1. The amounts itemized by fund and by department or office on the following schedule are hereby appropriated from the resources of each fund so itemized, the department or office listed in the first column on the same line of the schedule.

Section 2. Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective **January 4, 2016**.

Section 3. In accordance with Section 331.437, Code of Iowa, no department or county official shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution.

Section 4. If at any time during the **2015/2016** budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, she shall immediately so inform the Board and recommend appropriate corrective action.

Section 5. The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable departments and offices monthly, during the **2015/2016** budget year.

Section 6. All appropriations authorized pursuant to this resolution lapse at the close of the business day on **June 30, 2016**. The **2015/2016** fiscal year budget appropriated and accounted for by department and fund is as follows:

Consideration of Amendment to Section 5.1(g) of the Regional Mental Health 28E Agreement

Chairperson Helmrichs stated that the Mental Health Region has been discussing the funding mechanism of said region to help even out what each county is contributing per capita. Since the state limits the amount that each county can levy, the governance board decided that the new funding mechanism would have to be a combination of tax levy and fund balance utilization. The Delaware County Board of Supervisors met in work session this date at 3:00 p.m. with all members present. Also present were Connie Behnken, Tim Vick, Mary Ann Poynor, Dean Sherman, Dan Stelken, Milt Kramer, Erin Learn, Carla K. Becker and one member of the media. Chairperson Helmrichs called the meeting to order.

Future of Tourism in Delaware County

In light of the recent resignation of the current Delaware County Tourism Director, Manchester City Administrator Tim Vick feels that the position should move from contracted services to full-time under one of the public entities it serves. The City of Manchester is looking at the possibility of adding a part-time Marketing/Communications position to its staff. Perhaps something could be worked out to make this a full-time position and add county-wide tourism to the responsibilities. He is asking what the county's expectations are for the position and if it would be possible to work together.

Supervisor Madlom stated that the County is currently contributing \$6,000 towards tourism. Personally, Mr. Madlom feels the position should remain under the Tourism Committee with direct oversight of Delaware County Economic Development (DCED). The county has no office space available. However, he does feel that the position needs to be separate from the proposed city position. The Board needs to be accountable to everyone in the county. He does not feel the small communities and rural residents would like a joint position.

According to Mr. Vick, the City of Manchester is currently contributing \$12,000 per year to tourism; \$5,000 from the city's general fund and \$7,000 from the hotel/motel tax. Even though Manchester needs to have a marketing position, they are not sure there is enough work to make it full-time.

Councilperson Dean Sherman stated that the recent planning session that the council undertook showed that one of the priorities of the City of Manchester was to have a marketing position. He thought that they could perhaps partner with either the Manchester Chamber or DCED. With Jack Klaus announcing his intent to retire, he thought perhaps the Chamber would be a good fit. However, Mr. Klaus feels the Chamber Director's position is already a full-time position and could not take on any more.

Councilperson Mary Ann Poynor stated that perhaps the Extension Office would have an open office for this position and might also be willing to act as the agent overseeing the position.

Supervisor Helmrichs seemed open to the concept of a shared position. However, she would like to see some form of time management tracking similar to what the county is doing with the employees being shared with Dubuque County. Councilperson Sherman did not feel this would be necessary since the City of Manchester is part of Delaware County and the position would serve all of Delaware County. He also feels that the more money you are able to put towards a Tourism Director the better person you will get.

In summation Mr. Vick stated the following:

1. The Delaware County Board of Supervisors is interested in maintaining a tourism position within the county.
2. The City of Manchester has marketing as a priority.
3. Need somewhere for this position to be housed; DCED, Extension or City of Manchester
 - a. There is still an old Community Life office available in the front of the Council Chambers

Mr. Vick would like to put together a task force to look into these issues so that they did not have to bring the entire council together for each meeting. The City of Manchester would like to have something ironed out before February 1st if possible.

The current membership of the Tourism Committee is as follows:

Julie Smith, Jack Klaus, Bev Rahe, Donna Boss, Lori Scovel, Mary Ann Poynor, Elise Bergan, Laura Kammermeyer and Jeannie Domeyer.

According to Donna Boss, there is no formal process to being appointed to the Tourism Board; those who wish to serve on the Board are welcomed aboard. They currently meet the first Tuesday of every month at noon at the DCED Office.

Consideration of Purchase of New Optical Scan Voting Equipment

Consideration of Iowa DOT Preconstruction Agreement – Dyersville Interchange Project

Last week the Board tabled consideration of this agreement because there were several points within the agreement that Board members were not comfortable with. Mr. Art Gourley, with the Iowa Department of Transportation, is in attendance at today's meeting to discuss any issues the Board has with the language in said proposed agreement.

Supervisor Madlom stated that he was concerned with the agreement placing maintenance responsibilities within the new project areas even though it is his understanding that the City of Dyersville has agreed to be responsible for these areas and is intending to annex the area into its corporate limits.

According to Mr. Gourley, the existing agreement with the City of Dyersville states that the city will be responsible for all new improvements except for mainline US Hwy 20 and/or access ramps. Since the City of Dyersville has agreed to take on the responsibility for maintenance on all new improvements, then the county will have no responsibility for maintenance.

In light of the City of Dyersville's agreement language, the Board feels that the language in the County's agreement is misleading and overlaps with the city agreement. Mr. Gourley stated that he could request that the overlapping language on structures be removed from the current proposed preconstruction agreement prior to the Board's consideration.

Motion made by Dabroski, second by Madlom and carried to table the consideration of the IA DOT Preconstruction Agreement regarding the Dyersville Interchange Project until an amended agreement is received from the IA DOT removing any reference to county maintenance of structures. All Ayes

Discussion and Possible Action Regarding Right-of-Way Issue on 240th Ave in Section 20-90-4

It was brought to the Board's attention that the County Engineer's Office, Auditor's Office and Assessor's Office have been researching a portion of 240th Ave right-of-way being south of the Town Of Greeley and east of the Greeley Cemetery located in the Southeast Quarter (SE ¼) of the Northeast Quarter (NE ¼) of Section 29 of Elk Township. Research found that the current county right-of-way is 33 feet off the quarter section line. Unfortunately, the roadway does not follow the quarter line but rather curves to the northwest corner of the Section. To compound the issue, the county's taxation records show that the current title holder to the property under the existing roadway is either deceased or has moved away. Without a property owner to grant easement, it will be difficult to correct the issue.

This right-of-way issue was presented to the Delaware County Attorney's Office for review and potential resolution. It was noted that the Greeley Cemetery Association was planning to quiet title a portion of the Southeast Quarter (SE ¼) of the Northeast Quarter (NE ¼) of Section 29 of Elk Township lying southwest of the centerline of 240th Ave as now traveled. Assistant County Attorney Courtney Vorwald is requesting permission to seek quiet title to that portion of the parcel in question lying northeast of the centerline of 240th Ave as now traveled. Once both quiet titles are approved through the court systems, the Secondary Road Department could then pursue the acquisition of the remainder of right-of-way needed in the area being acquired by the Cemetery Association.

The Delaware County Board of Supervisors met in work session this date at 2:00 p.m. with all members present. Also present were John LeClere, Mike Ryan, Carla K. Becker and one member of the media. Chairperson Helmrichs called the meeting to order.

Emergency Management Commission Funding FY2016-17 and Budget Overview

Emergency Management Coordinator Mike Ryan addressed members of the Emergency Management Commission Executive Board and Board of Supervisors regarding funding for the Commission's proposed 2016-17 Budget. Since this is the first year that the EMA Department has been completely separate from the county, it will be hard to do a comparison of this year's proposed budget to prior years.

Mr. Ryan presented the Board with a copy of the proposed EMA Budget for FY 2016-17. Within said proposal is a 10% increase in salary for Mr. Ryan's position as coordinator, \$4,750.00 for rental of 2 storage units and the EMA office in Earlville, \$15,000 for the purchase of an SUV or pickup, \$2,000 for a new computer, \$25,000 for special projects (mobile command center, construction of new building, breathing air trailer etc.) and \$6,500 to replace EMA radios.

Mr. Ryan also stated that he would like to start a "contingency fund" by allotting \$25,000 per year. Said fund would help pay for items needed in a large disaster. When asked how this money could help people in the rural community, Mr. Ryan responded that the money would not be able to be used for private individuals. Most likely it would be used for public infrastructure. He added that, in his opinion, it will be much harder to get disasters declared on the federal level.

The total proposed expenditures for FY 2016-17 was \$144,376 (\$169,376 - \$25,000 Contingency fund). Of this amount, \$16,450 is for expenditures which could possibly be covered by the 911 Services Board since all property transferred to them last fall. This would leave a total expenditure level of \$127,926 being proposed.

Mr. Ryan stated that at its meeting in the spring of 2015, the EMA Commission indicated that they would like to move to a county-wide levy for its main funding stream. Currently, the Commission has a combination of county-wide levy and per capita levies amongst the cities and the county.

With outside revenues of \$25,850 (\$25,500 EMPG & \$350 Misc), Mr. Ryan is requesting \$143,526 through a county-wide levy to fully fund his budget. With current valuations that would be 12.85 cents per thousand dollars of valuation. When asked about a potential fund balance carryover for the current year, Mr. Ryan stated that he was anticipating a \$68,000 carryover this year. Adding in the requested county-wide levy and miscellaneous revenue, the proposal would potentially leave an ending fund balance of almost \$90,000 if the 911 Services Board took on the additional expenditures. This would be approximately a 70% carryover. The state highly recommends no more than a 25% unassigned carryover for all authorities.

Members of the Board of Supervisors were not in favor of funding a "contingency fund". They felt that if it could only be used for public entity infrastructure, then it would not be of much use in the rural communities. Supervisor Madlom also wished that some of the city officials on the EMA Commission would spend more time being appreciative of the county and what they have done, and continue to do.

After a brief discussion on funding, the following funding levels were calculated:

Currently, the Board of Supervisors levying approximately \$80,000 within the general supplemental fund to support EMA and the incorporated cities are levying not quite \$9,000 combined. If they move to funding EMA only through a county-wide levy, it would need to raise no less than \$89,000 to maintain the current level of funding. With a proposed expenditure level of \$127,926 (after the reduction of probable 911 expenditures) and a recommended carryover of approximately \$32,000 (127,926 x 25%) the funding level should fall somewhere between \$90,000 and \$100,000 according to the county budget director. Even if 911 did not cover the 16,500 in equipment expenses AND the EMA Commission expended its entire budget (\$144,376), if the county-wide levy provided 100,000 in revenue, the EMA Commission would still have a projected \$49,124 (34%) carryover at the end of FY 2016-17. Any increase in funding past the \$100,000 level would just increase the projected carryover at the end of the fiscal year.

The Board of Supervisors are currently within their budget process. The setting of a funding level will need to be acted on within an open board meeting. The Board thanked Mr. Ryan and the EMA Executive Board for meeting with them.

The work session was adjourned at 3:20 pm.

Communication Center Annual Report – James Hauschild, Manchester Chief of Police

James Hauschild, Manchester Chief of Police, addressed the Board regarding the Communication Center. Per a 28E Agreement, the Communication Center is funded 60% by Delaware County and 40% by the City of Manchester with the operation being located within

the same building as the Manchester Police Department. Chief Hauschild stated that there have been many changes and updates to the center recently that have improved the services provided to deputies, officers and the community. Some of the major accomplishments listed include the following:

1. Hiring of two part-time dispatchers to relieve pressure on staff scheduling.
2. Completed installation of Next Gen 911 equipment to prepare for activation of system by the State of Iowa. This is to allow for texting, and eventually sending video, for 911 emergencies.
3. Switched radio system to P25 to prepare for FCC narrow banding and improve radio reception. Narrow banding dropped the center's coverage. The P25 equipment brought the coverage and clarity back up.
4. Installed new digital recorder in dispatch center. Now every phone line coming into the center is being recorded.
5. Installed new digital phone system in dispatch center.
6. Installed heating and cooling system in second floor of building to increase the usable office space. This additional office space is being utilized by lead dispatcher Loretta Welcher.
7. Policy manual for communications center nearly complete.
8. Started an annual employee review process.
9. Hosted a hostage negotiation training conducted by the FBI to over 50 officers and dispatchers from multiple departments.

One thing to consider in the future is that three certified dispatchers will be retirement age in the near future. Finding individuals that are willing to work a 24/7/365 service is becoming more and more difficult according to Chief Hauschild. He feels that having quality part-time staff is the key. One or two of the current part-time dispatchers could move into full-time position. He would also like to hire a 3rd part-time dispatcher to increase the pool of potential full-time employees. The cost of training and certifying a new dispatcher from scratch is estimated at \$12,000 - \$16,000. Utilizing existing part-time staff would greatly reduce this cost.

Tim Vick, Manchester City Manager, apologized for the delay in getting the quarterly invoices/reports to the Board and Sheriff. Mr. Vick stated that a change in software has created the backlog.

The Board thanked Chief Hauschild and Mr. Vick for the updates.

Discussion and Possible Action Regarding Delaware County Tourism

The Board has met on this issue twice already; once with all stakeholders and once with the City of Manchester. Although the Board feels that tourism needs to be a partnership of all stakeholders, they do not feel the county should share a full-time position with the City of Manchester. All three Board members have their own idea as to the level of county contribution. Proposed levels range from \$6,000 to \$8,000 annually.

During the meeting with the City of Manchester it was suggested by Councilwoman Poynor that perhaps Ag Extension would have a vacant office that the Tourism Coordinator could use. Unfortunately, Ag Extension has no space. However, Donna Boss, Economic Development Director, stated that they do have a small office area that the Tourism Coordinator could use. Having the office with Economic Development would be perfect since that is the entity the Board would like this position to report to.

Manchester City Manager Tim Vick stated that the City is committed to \$12,000 in FY 2016-17. However, the City could also help funding the matching dollars needed for grants on any specific item that would benefit the City.

Supervisor Helmrichs stated that the County has been partnering with tourism in more ways than just monetary donations. The addition of the Whitewater Park in Manchester has some unintended consequences with parking and traffic at Bailey's Ford Park. The County created a separate access and parking areas at the park to deal with the aftermath of the city's successful project.

No further action will be taken at this time. The Board thanked Mr. Vick for attending.

RESOLUTION 2016-006 FY 2016-17 Emergency Management Funding

WHEREAS, the Delaware County Board of Supervisors understands the important role that the Emergency Management Commission plays within Delaware County; and

WHEREAS, Chapter 29C.17 creates a local emergency management fund within the County Treasurer's Office; and

WHEREAS, per 29C.17 (2) the Emergency Management Commission has chosen in the past to be funded by both a county-wide special levy pursuant to section 331.424(1) and a per capita allocation funded from city and county general funds; and

WHEREAS, now said Emergency Management Commission has voted to pursue funding only through a county-wide special levy pursuant to section 331.424(1); and

WHEREAS, Mike Ryan, Delaware County EMA Coordinator, met in work session with the Delaware County Board of Supervisors on Monday, January 25, 2016 at 2:00 pm to review the proposed Emergency Management budget and to request funding from the Board by county-wide special levy.
