The Delaware County Board of Supervisors and ex-officio Board of County Canvassers, for Delaware County, Iowa, met to certify the votes cast in this county at the Regular Municipal Election held on the 3rd day of November, 2009, as shown by the tally lists returned from the election precincts of the cities not opting for run-off. Shirley E. Helmricks, Chairperson, called the meeting to order at 12:45 P.M., with all members present. Results of the canvass were as follows:

Colesburg Corp – For the office of Mayor, there were fifty-seven (57) total votes cast of which Richard Sampson received fifty-three (53) votes, Fred Bush received one (1) vote, David Phelps received one (1) vote, Evert Klaus received one (1) vote and Toby Bockenstedt received one (1) vote. Richard Sampson was declared elected for a term of two (2) years.

Chris Roling was declared elected for a term of two (2) years.

For the office of City Council, there were one hundred seven (128) total votes cast of which Merlyn V. Andersen received twenty-three (23) votes, Timothy Glass received nineteen (19) votes, Lonnie Fishler received eighteen (18) votes, Steve McAreavy received eighteen (18) votes, Rick Lahr received eleven (11) votes, Bob J. Nefzger received ten (10) votes, Kevin Clark received seven (7) votes, Barb Ries received four (4) votes, Amy Anderson received four (4) votes, Elizabeth Fishler received four (4) votes, Trish Glass received two (2) votes, Elaine Nachtman received one (1) vote, Bev McAreavy received one (1) vote, Becky Huber received one (1) vote, Rocky Tibbott received one (1) vote, Jason Reeves received one (1) vote, Larry Tibbott received one (1) vote, Theresa Fishler received one (1) vote, and Marion Peters received one (1) vote. Merlyn Andersen, Lonnie Fishler, Steve McAreavy, Timothy Glass and Rick Lahr were declared elected for a term of two (2) years.

Delhi Corp – For the office of Mayor, there were sixty-three (63) votes cast of which Terry Harbach received sixty-two (62) votes and Linda Jay received one (1) vote. Terry Harbach was declared elected for a two (2) year term.

For the office of City Council, there were one hundred eighty-four (184) total votes cast of which Duane Gibbs received sixty (60) votes, Paul Lechtenberg received sixty-one (61) votes, Greg Preussner received sixty (60) votes, Laurie Kramer received one (1) vote, Sheryl Schnittjer received one (1) vote and Darwin Mesch received one (1) vote. Duane Gibbs, Paul Lechtenberg and Greg Preussner were declared elected for a term of four (4) years.

Dundee Corp – For the office of Mayor, there were sixty-six (66) total votes cast of which Barb Robinson received fifty-seven (57) votes, Terry Conrad received seven (7) votes and Lynn Sites received two (2) votes. Barb Robinson was declared elected for a term of two (2) years.

For the office of City Council, there were one hundred thirteen (113) total votes cast of which Vernon Feldman received fifty-one (51) votes, Tom Gibbs received twenty-seven (27) votes, Glenn Puffett received twenty-two (22) votes, Ed Gibbs received nine (9) votes, Don Boeding received one (1) vote, Latricia Conrad received one (1) vote, Aaron Waugh received one (1) vote and Barbara McDowell received one (1) vote. Vernon Feldmann and Tom Gibbs were declared elected for a term of four (4) years.

Earlville Corp – For the office of Mayor, there were seventy-six (76) total votes cast of which Dan Wheeler received sixty-eight (68) votes, Wayne Hermsen received four (4) votes, Shannon Richardson received two (2) votes and Bob Kehrli received two (2) votes. Dan Wheeler was declared elected for a term of two (2) years.

For the office of City Council, there were one hundred sixty-two (162) total votes cast of which Mark Salow received fifty-two (52) votes, Shannon Richardson received forty-six (46) votes, Daryld Lewin received seven (7) votes, Rick Hillebrand received six (6) votes, Jules Uldrich received five (5) votes, , Jeff Thomas received four (4) votes, Wayne Hermsen received four (4) votes, Bob Kehrli received three (3) votes, Dale Smock received three

Kaiser received twenty-three (23) votes, Joel Kaiser received twenty-three (23) votes, Chuck Rettinger received twenty-three (23) votes, Mike Francois received one (1) vote, Nellie Marting received one (1) vote, and Herman Marting received one (1) vote. Kenneth Clemen, Sherry Davis, Daniel J. Kaiser, Joel Kaiser and Chuck Rettinger were declared elected for a term of two (2) years..

Ryan Corp – For the office of Mayor there were ninety-one (91) votes cast of which Mike Corcoran received forty-six (46) votes, Tony J. Zieser received forty (40) votes, Dennis Glynn received one (1) vote, John Enabnit received one (1) vote, Ingrid Quint received one (1) vote, and two (2) votes were blank. Mike Corcoran was declared elected for a term of two (2) years.

For the office of City Council, there were two hundred nineteen (219) total votes cast of which John Britt received sixty-nine (69) votes, Tiffany Feldmann received seventy-five (75) votes, Kesha Kaiser received sixty-eight (68) votes, Tom Oleson received one (1) vote, James Glynn Jr. received one (1) vote, Marilyn Zieser received one (1) vote, Bonnie Sauser received one (1) vote, Lorraine Gaffney received one (1) vote, Revette Sauser received one (1) vote and Leland Reiss received one (1) vote. John Britt, Tiffany Feldmann and Kesha Kaiser were declared elected for a term of four (4) years.
