Summary: To authorize imposition of a local sales and services tax in the City of Hopkinton at the rate of one percent (1%) to be effective from January 1, 2020 until December 31, 2029.

A local sales and services tax shall be imposed in the City of Hopkinton, Iowa at the rate of one percent (1%) to be effective January 1, 2020 until December 31, 2029.

Revenue from the local option sales and services tax are to be allocated by the City of Hopkinton as follows:

0% for property tax relief; a specific purpose for which the revenues shall otherwise be expended is:

100% of the revenues will accrue to the General Fund of the City to provide a contingency for unseen emergencies and/or opportunities and any other lawful purpose to be determined by the City Council and future City Councils.
