## **PUBLIC MEASURE B**

### **SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?**

Summary: To authorize a change in the use of the one percent (1%) Local Sales and Services tax in the City of Masonville, Iowa effective July 1, 2017.

The use of the one percent (1%) Local Sales and Services tax shall be changed in the City of Masonville, Iowa effective July 1, 2017.

#### **PROPOSED USES OF THE TAX:**

If the change is approved, revenues from the sales and services tax shall be allocated as follows:

0% for property tax relief;

The specific purposes for which revenues shall otherwise be expended are as follows:

20% for Sewer Maintenance

80% for General Fund

#### **CURRENT USES OF THE TAX:**

Revenues from the sales and services tax are currently allocated as follows:

0% for property tax relief;

The specific purposes for which revenues shall otherwise be expended are as follows:

20% for Sewer System Improvements/Maintenance

20% for Fire Department/First Responders

60% for Street Improvements
