2011 SCHOOL ELECTION

PUBLIC NOTICE IS HEREBY GIVEN that the regular school election for the Maquoketa Valley Community School District, in the County of Delaware, State of Iowa, will be held on Tuesday, September 13, 2011.

Polls will be open from 12:00 pm (Noon) until 8:00 pm. Pre-Election Day voter registration, for this election, will close Friday, September 2, 2011 at 5:00 pm. It is highly recommended that those persons wishing to vote in this election pre-register on or before the September 2, 2011 deadline. However, in January 2008, Iowa law was adopted to allow eligible persons the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Please bring a valid and current photo ID which has an expiration date. If the address on your ID is not current, you will need to prove residency. The following documents can be used as proof of residency if they contain your name and current address: Residential lease, Property tax statement, Utility bill, Bank statement, Paycheck, Government check or other Government document. If you do not have proof of residence and identity, a registered voter in your precinct may attest for you. You will both be required to sign an oath. To request an absentee ballot, use the official form available at the Delaware County Auditor's Office, or at the county's website at www.co.delaware.ia.us or at the Secretary of State's website at www.sos.state.ia.us, and mail it to the Delaware County Commissioner of Elections, 301 E. Main St., Room 210, Manchester, Iowa 52057. The last day to request an absentee ballot by mail is Friday, September 9, 2011 at 5:00 pm. In person absentee voting is available at the Delaware County Auditor's Office thru 11:00 am on Tuesday, September 13, 2011. The precincts and polling locations for the Maquoketa Valley Community School District will be as follows:

Precinct #1 - Earlville Civic Center for the Cities of Delaware and Earlville and that part of Elk Township, Delaware Township, Oneida Township and Bremen Township that is in said district.

Precinct #2 - Delhi Community Center for the City of Delhi and that part of Milo Township, Delhi Township and North Fork Township that is in said district.

Precinct #3 - Hopkinton Community Center for the City of Hopkinton and that part of South Fork Township, Hazel Green Township and Union Township that is in said district.

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. Voting equipment to be used in this election will be tested and certified on Friday, September 9, 2011 at 9:00 am in the Jail Basement located within the courthouse at 301 East Main Street, Manchester, Iowa. The public is invited to attend.
