The Delaware County Board of Supervisors and ex-officio Board of County Canvassers, for Delaware County, Iowa, met to certify the votes cast in this county at the Regular School Election held on the 8th day of September, 2009, as shown by the tally lists returned from the election precincts. Shirley E. Helmrichs, Chairperson, called the meeting to order at 11:00 A.M. Results of the canvass were as follows:

EDGEWOOD-COLESBURG COMMUNITY SCHOOL DISTRICT

For the Office of Director District #1, there were two hundred thirty (230) votes cast of which Steve Schwietert received two hundred five (205) votes; Jeff Lincoln received twenty-one (21) votes; Douglas Moser received two (2) votes; Rex Meyer received one (1) vote and Perry Sampson received one (1) vote. **Steve Schwietert was declared elected for the term of four (4) years.**

For the Office of Director District #2, there were two hundred forty-nine (249) votes cast of which Jason Jones received one hundred thirty-six (136) votes and Scot Christiansen received one hundred thirteen (113) votes. **Jason Jones was declared elected for the term of four (4) years.**

For the Office of Director – At Large, there were two hundred fifty-two (252) votes cast of which Jeff Lincoln received one hundred twenty-nine (129) votes and Michelle Rochford received one hundred twenty-three (123) votes. **Jeff Lincoln was declared elected for a term of four (4) years.**

MAQUOKETA VALLEY COMMUNITY SCHOOL DISTRICT

For the Office of Director District #2, there were two hundred thirty-nine (239) votes cast of which Douglas G. Dabroski received one hundred eighty-six (186) votes; Lance Smeins received forty-eight (48) votes; Linda Goldsmith received two (2) votes; Craig Davis received one (1) vote; Dan Wheeler received one (1) vote; and June Wooten received one (1) vote. **Douglas G. For the Office of Director District #4, there were two hundred thirty-seven (237) votes cast of which Kay Harris received one hundred forty-eight (148) votes; Steve Tucker received forty-two (42) votes; Steve Dircks received thirty-four (34) votes; Sue Guthrie received four (4) votes; Craig Davis received three (3) votes; Frog Marug received one (1) vote; Amy Ries received one (1) vote; Steve Huber received one (1) vote; Katie Book received one (1) vote; Doug Melchert received one (1) vote; and Lance Smeins received one (1) vote. **Kay Harris was declared elected for a term of four (4) years.**
