SPECIAL ELECTION

PUBLIC NOTICE IS HEREBY GIVEN that a special election for the Edgewood-Colesburg Community School District, in the Counties of Clayton and Delaware, State of Iowa, will be held on Tuesday, February 7, 2017.

Polls will be open from 12:00 pm (Noon) until 8:00 pm. Pre-Election Day voter registration, for this election, will close Friday, January 27, 2017 at 5:00 pm. It is highly recommended that those persons wishing to vote in this election pre-register on or before the January 27, 2017 deadline. However, in January 2008, Iowa law was adopted to allow eligible persons the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Please bring a valid and current photo ID which has an expiration date. If the address on your ID is not current, you will need to prove residency. The following documents can be used as proof of residency if they contain your name and current address: Residential lease, property tax statement, utility bill, bank statement, paycheck, government check or other government document. If you do not have proof of residency and identity, a registered voter in your precinct may attest for you. You will both be required to sign an oath. Any questions regarding Election Day Registration may be directed to the Delaware County Auditor's Office at (563) 927-4701.

To request an absentee ballot, use the official form available at the Delaware County Auditor's Office, or at the county's website at www.co.delaware.ia.us or at the Secretary of State's website at www.sos.state.ia.us, and mail it to the Delaware County Commissioner of Elections, 301 E. Main St., Room 210, Manchester, Iowa 52057. The last day to request an absentee ballot by mail is Friday, February 3, 2017 at 5:00 pm. In person absentee voting is available at the Delaware County Auditor's Office thru 11:00 am on Tuesday, February 7, 2017. The precincts and polling locations for the Edgewood-Colesburg Community School District will be as follows:

Precinct #1 - Colesburg Community Center for the City of Colesburg and that part of Colony Township and Elk Township in Delaware County and Mallory Township in Clayton County that is in said school district.

Precinct #2 - Edgewood City Hall for the City of Edgewood and that part of Honey Creek Township and Richland Township in Delaware County and Lodomillo Township, Volga Township and Elk Township in Clayton County that is in said school district. ****

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle.
