

**PUBLIC NOTICE
NORTHEAST IOWA COMMUNITY COLLEGE
SPECIAL ELECTION**

PUBLIC NOTICE IS HEREBY GIVEN that a Special Election for the Northeast Iowa Community School District in the County of Delaware, State of Iowa, will be held on Tuesday, September 11, 2018. Polls will be open from 12:00 p.m. (noon) until 8:00 p.m.

Voters are required to provide an approved form of identification at the polling place before they may receive and cast a ballot. However, pre-registered voters who are unable to show approved identification may sign an oath of identification for an election held in 2018. Pre-registration for this election will close on Friday, August 31, 2018 at 5:00 p.m. It is highly recommended that those persons wishing to vote in this election pre-register on or before the August 31, 2018 deadline. Voters who are not pre-registered or who have changed precincts will also be required to provide proof of residence. The following documents may be used as proof of residency if they are current to within 45 days of submission and contain your name and current address: Tax statement, residential lease, utility bill, bank statement, paycheck, government check or other government document. Any voter who cannot show ID may have their identity attested to by another registered voter in the precinct who has proper ID. Starting January 1, 2019, all voters will be required to present an approved form of identification. To request an absentee ballot, use the official form available at the Delaware County Auditor's Office, the county website at www.co.delaware.ia.us or at the Secretary of State's website at www.sos.state.ia.us, and send it to the Delaware County Commissioner of Elections, 301 E. Main St., Room 210, Manchester, Iowa 52057. The last day to request an absentee ballot by mail is Friday, August 31, 2018 at 5:00 p.m. In person absentee voting is available at the Delaware County Auditor's Office thru 11:00 a.m. on Tuesday, September 11, 2018.
